- Site plan showing pool placement in relation to property lines, septic systems and spray heads (if applicable), pool equipment and all other structures on property.
- Pool plan showing the deck drainage, pool drainage, overflow drainage and sanitary sewer connection (if applicable).

**Requirements**

- All backwash must go to storm drain
- Pool must be completely enclosed by a four (4) foot fence with self closing, self latching gate.
- Pool deck and equipment may not be placed in an easement.
- Anti-siphon hose bibs must be placed on all outside faucets.
- Construction fencing must be in place at all times that site is unattended.
